

Don't forget to claim your age-related benefits

Our records show that you will soon be turning 60. You may have thousands of dollars in benefits waiting for you to claim.

Start applying now for the benefits that you are eligible for.

As with most things, there is some paperwork involved. Depending on the benefit, the application process could take several weeks to complete. It's a good idea to start applying early. Don't worry, **if you have questions or need help, support is available (see bottom of page 3 for more information).**

Allowance Program (Age 60-64) <i>If your spouse or common-law partner is eligible to receive the Guaranteed Income supplement (GIS - for 65+), you may qualify.</i>	Maximum payment amount \$1,305.71 / month Your spouse or common-law partner must be receiving GIS for you to qualify for the Allowance Program.	<ul style="list-style-type: none"> Apply online using your My Service Canada Account (MSCA). <p>Low Income Seniors benefit (Age 60+)</p> <p>To qualify, you must be receiving at least one of the following federal benefits:</p> <ul style="list-style-type: none"> • Guaranteed Income Supplement • Allowance for Survivor Program • Allowance Program (between 60 and 64 years old) 	<p>\$400.00 / year</p> <p>If both spouses/common-law partners live in the same household, only one \$400.00 benefit will be granted.</p> <p>If spouses live separately (for example, one residing in a nursing home), both will be eligible for the benefit.</p>	<ul style="list-style-type: none"> • A \$200 affordability supplement will automatically be issued to you if you received the \$400 Low-Income Seniors' Benefit for the 2023 benefit year. • If you are eligible to receive this benefit, but have not yet applied, you have until December 31, 2023 to apply. You would receive the full amount of \$600 (\$400 benefit plus \$200 supplement) in January 2024. • Applications for the 2024-2025 benefit year to receive the \$400 Low-Income Seniors' Benefit and \$200 Affordability Supplement will open on April 1, 2024. • Apply online or by paper yearly. <p>If you have worked and have a disability, you may qualify for the following:</p>		
<p>Canada Pension Plan Disability Benefits (Age 60-64)</p>	<p>Minimum basic payment amount is \$558.74 / month plus additional money depending on how much and for how long you paid into the CPP. Maximum payment \$1,538.67/month.</p> <p>When you turn 65 your CPP disability benefit is automatically changed to a CPP retirement pension.</p>	<ul style="list-style-type: none"> • Apply online using your My Service Canada Account (MSCA). Visit www.canada.ca/msca. • To apply by paper, download the application at www.canada.ca (search 'CPP disability').
<p>POTENTIAL AMOUNT</p>	<p>\$ 558.74 – 1,538.67 / month (amount varies depending on CPP contribution).</p>	

<p>If your spouse or common-law partner has passed away, you may qualify for the following:</p>		
<p>Canada Pension Plan Survivor's Pension (Under the age of 65)</p> <p>A monthly payment paid to the legal spouse or common-law partner of the deceased contributor.</p>	<p>If you are not receiving other CPP benefits, you will receive a flat rate portion and 37.5% of the contributor's CPP.</p> <p>If you already receive a Canada Pension Plan (CPP) retirement pension or disability pension, the survivor's pension will be combined into a single monthly payment.</p>	<ul style="list-style-type: none"> • Apply online using your My Service Canada Account (MSCA). Visit www.canada.ca/msca. • To apply by paper, download the application at www.canada.ca (search 'survivor's pension').

<p>Allowance for the Survivor (Age 60-64)</p> <p><i>If your spouse or common-law partner has died and since their death you have not remarried or become a common-law partner to another person.</i></p>	<p>Maximum payment amount \$1,556.51 / month</p>	<ul style="list-style-type: none"> • Apply online using your My Service Canada Account (MSCA). Visit www.canada.ca/msca. • To apply by paper, download the application and the Statement of Income form at www.canada.ca (search 'Guaranteed Income Supplement').
<p>POTENTIAL AMOUNT</p>	<p>\$1556.51 / month + 37.5% of spouse/common law's CPP (amount varies depending on eligibility and CPP contribution).</p>

If you would like to apply for services online, you will need to sign in to or create a My Service Canada Account (MSCA). My Service Canada Account is a secure online portal that allows you to view your personal income tax and benefits, set up direct deposit, receive email notifications, apply for benefits, and more.

To access your My Service Canada Account, sign in or create an account at **Canada.ca/msca**. If you need help you can allow a trusted person to access your account on your behalf.

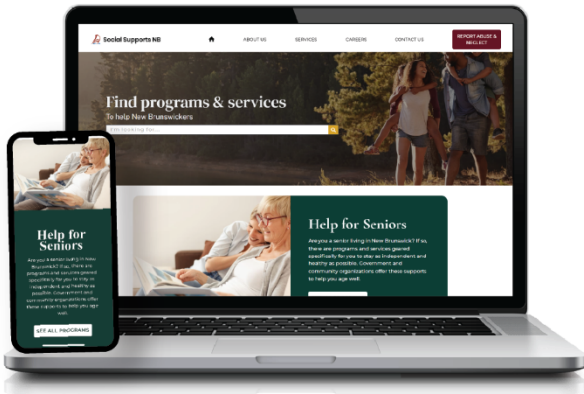
